Residents are asked to take a few minutes to answer some simple questions about natural, technological and intentionally human-caused hazards in the county, as well as what initiatives they would support to reduce impacts from those hazards.

Ashtabula County EMA Planner/Trainer Alicen F. Limestoll said the plan is updated every five years, as required by the Federal Emergency Management Agency.

Resident input is strongly encouraged on the survey.

"They're all over the county. They might see something the rest of us don't see," Limestoll said.

The survey can be found at www.surveymonkey.com/r/AshtabulaCoHMP_Public. People may respond through the end of January.

Some of the questions asked on the survey include, "Have you noticed an increase in the occurrences or intensity of any of the following hazards?" The hazards mentioned include coastal erosion, drought, earthquake, flooding, severe thunderstorms and hail, severe wind and tornadoes, severe winter storms (blizzards, ice storms, heavy snow), dam failure,

hazardous materials incidents, fire (structure fires, brush fires) and terrorism or civil disturbance.

Survey responders are also asked if they have a 72-hour emergency kit in their home.

Another question asks responders to indicate the types of mitigation actions they would support, whether as something they can do, or an initiative by their officials. Choices include buying out properties, relocating homes, or elevating structures that are prone to repetitive flooding; upgrading the water and sewer systems; installing generators in critical facilities such as hospitals, police stations, fire stations, etc.; regulating the type of development that is permitted in areas that are dangerous due to hazards; planting trees to prevent erosion and promote cooler microclimates; promoting the collection and reuse of rainwater such as in rain gardens and green roofs; and more.


The information residents provide will help reduce vulnerability by guiding local leaders as they prioritize mitigation projects.
